- Our annual Children's Holiday Celebration, pays for it self with the entry fee and the thousands of dollars in gift, supplies, etc. donations

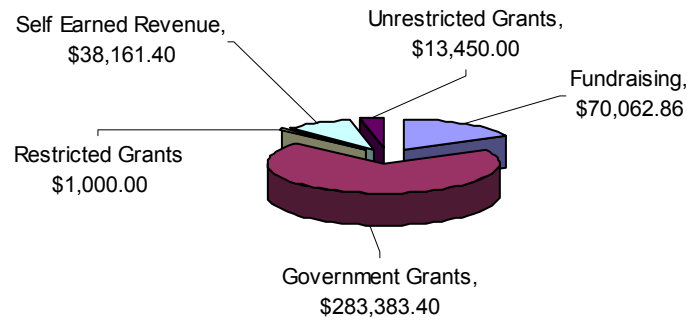
This year **almost 7,000** services were provided to community members, above is a detailed chart for our most frequently used programs.

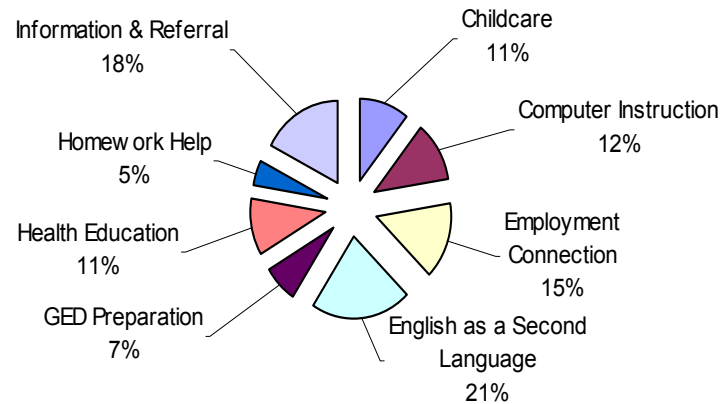
Revenues & Expenditures
